- 4. Except for the express manufacturer warranty, if any, which accompanies the product purchased, Wallwork Truck Center gives no warranties, either express or implied, including but not limited to warranties of merchantability or of fitness for a particular purpose.
- 5. This agreement shall be continuing unless mutually terminated by both parties in writing.
- 6. I further certify that I am an officer of Customer, knowledgeable of the financial conditions of Customer, and that I am empowered and authorized to enter into the aforesaid Agreement on Customer's behalf.
- 7. The undersigned has executed one or more Conditional Sales Contracts, Agreements, Purchase Agreements, Notes, and other related documents (collectively "Accounts") with Wallwork for parts purchases and or Service Work for vehicles or equipment.
